- If only registering in one competitive class, it must be the core Thursday class. The purpose of this technique class is to complement the core class.

PRIVATE LESSONS

Day: Wednesdays and/or weekends based on instructor availability.

Fee: \$30/60 minutes or \$15/30 minutes

Payment: Pay as you go.

CHOREOGRAPHY LESSONS

Day: Wednesdays and/or weekends based on instructor availability.

Fee: \$40/hour for private (includes fee for choreographing and music preparation)

\$20/hour per dancer in group of 2-3

\$15/hour per dancer in group of 4 or more

Outfit costs are the responsibility of the dancer/parent

Payment: Pay as you go.

Location:

All classes take place in the gym at Queen Elizabeth Elementary School, on Saunders Dr, Kensington. Please use the gym entrance which is located at the very far end of the parking lot.

Attire:

Dancers should be dressed in black body suit with tights or bare legs and white knee socks. If t-shirts are worn over top of body suit they must be tight fitting.

Highland dancing shoes (gillies) must be worn. Tartan Tots and Wee Kilties may wear black gymnastic slippers, but Wee Kilties should have Highland shoes by January 2011.

Hair must be in a pony tail or similarly pulled back neatly off the face.

Fees:

Annual fees have been calculated to include allowances for cancellations due to weather, school closures or any other reasons. There will be no make-up classes provided.

Refunds:

Refunds will be given with 1 full calendar month's notice. For example, if notice is given Feb. 15th then February as well as March payment will be retained, and April fees onward will be returned. No refunds will be provided for the 8-week Tartan Tots sessions.

Cancellations:

During the winter, please listen and watch local news websites for school closure announcements. If QEES is closed for the day, closed early, or closed for after school activities due to storm or other reason, all dance classes are cancelled because we do not have access to the facility. Dance students will be notified by email regarding cancellations for any other reasons and I will also try to post such cancellations on our website. If you are still unsure if classes are cancelled, you may call my cell at 902-888-1363 as I will record a special message regarding any cancellations on my voice mail.

Competition Instructor Fee:

In the 2010 - 2011 dance year, I will attend all PEI competitions plus two off-Island competition free of charge (Truro, NS – October, Sackville, NB – February). Should you wish me, as your dancer's instructor, to attend competitions with you and your dancer outside of those listed above, a fee of \$150/day, as well as \$0.40/km mileage will be charged. These fees may be divided among a group of dancers should multiple requests be made for instructor attendance. Requests should be made well in advance. Instructor attendance is based on availability. Payment due on or before day of competition.
